 Amendment to the Financing Agreement*

Dear Mr. Attygalle:

We refer to the Financing Agreement (“Agreement”) dated April 3, 2020, between the Democratic Socialist Republic of Sri Lanka (“Recipient”) and the International Development Association (“Association”), for the COVID-19 Emergency Response and Health Systems Preparedness Project (“Project”). We also refer to the letter from the Recipient dated October 20, 2020, requesting certain amendments to the Agreement.

The Association agrees to your request and proposes to amend the Agreement as follows:

1. Schedule 2, Section I.3 is hereby deleted in its entirety.
2. The table in Schedule 2, Section III.A is deleted in its entirety and replaced with the following:

4. A new definition is added in the Appendix to read as follows:

“Transportation Cost” means the costs incurred by the MoH to facilitate essential travel of health facility staff to deliver health services under the Project.

All other provisions of the Agreement, except as revised herein, remain unchanged.

Please confirm your agreement to the foregoing on behalf of the Recipient by countersigning and dating the corresponding form of confirmation set forth below and returning one fully countersigned original of this letter of amendment to us. Upon receipt by the Association of the original of this letter of amendment countersigned by you, this letter of amendment shall become effective as of the date of the countersignature.
