

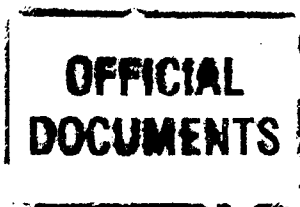

Amendment to the Administration Agreement between the Government of the Kingdom of Denmark and the International Development Association concerning the Multi Donor Trust Fund for Co-financing of Private Sector Competitiveness Project in Tanzania (Trust Fund No. TF071009)
Extension of End Disbursement Date

We refer to the Administration Agreement ("Agreement") between the Government of the Kingdom of Denmark (the "Donor") and the International Development Association ("IDA") ("World Bank"), regarding the Multi Donor Trust Fund ("MDTF" or "Trust Fund") for the Co-financing of Part (B) of the Tanzania Private Sector Competitiveness Project ("IDA-4136 TA"). We also refer to recent discussions between IDA and the Donor to extend the End Disbursement Date of the MDTF.

We, therefore, propose to amend paragraph 8.1 of Annex 2 to the Agreement as follows:

"8.1. It is expected that the Contribution funds will be fully disbursed by IDA in accordance with the provisions of this Agreement by December 31, 2013. IDA shall only disburse Contribution funds for the purposes of this Agreement after such date with the written approval of the Donors."


All other terms of the Agreement, except amended herein, shall remain the same.

It is the Bank's policy to make publicly available the Administration Agreement and any information related thereto, including this Amendment. By confirming its agreement below, the Donor consents to disclosure of this Amendment after it has become effective.

We propose that this letter shall constitute an amendment to the Administration Agreement between the Bank and the Donor. Please confirm your acceptance to the foregoing, on behalf of the Donor, by signing and dating the two originals, retaining one original for your records and returning the other original to the Bank. Upon receipt by the Bank of the original Amendment countersigned by you, this Amendment will become effective as of the date of the countersignature.
