### Implementation Status and Key Decisions

The project has been under implementation for 6 months since being declared effective on May 08, 2015. This initiative is being supported through a recipient executed grant through the multi-donor trust fund for Cooperation in International Waters in Africa (CIWA) and in parallel by financial support from DANIDA. Significant progress has been made by the ZAMCOM Secretariat to realize the project's development objective. The project is on track and has already realized some results.

Component 1 is aimed at providing support for a more financially sustainable and efficient basin-wide water resources institution. The permanent ZAMCOM Secretariat has been established and is largely financed through Member State contributions.

Component 2 is aimed at providing support the operationalization of the Zambezi Water Information Management System (ZAMWIS). This is part of



a multi-donor initiative to provide a foundation for more effective information sharing and decision support systems within the Zambezi River Basin. This component is being supported by DANIDA and CIWA who, based on guidance from ZAMCOM, have share subcomponents. The activities are on track with consultants supported through DANIDA having been contracted and have commenced activities in support of Phase 1. The planned outputs from this intervention are near completion and Phase 2 supported through the CIWA financing are at an advanced stage. Component 3 is aimed at supporting development of the Zambezi Strategic Plan for the efficient management and sustainable development of the Zambezi Watercourse. This component is on track. ZAMCOM official prepared at concept note for the development of the strategy which was adopted by the Council of Ministers. Based on the concept note draft ToRs have been developed and are currently under review. The procurement for services was commenced and is now at an advanced stage.

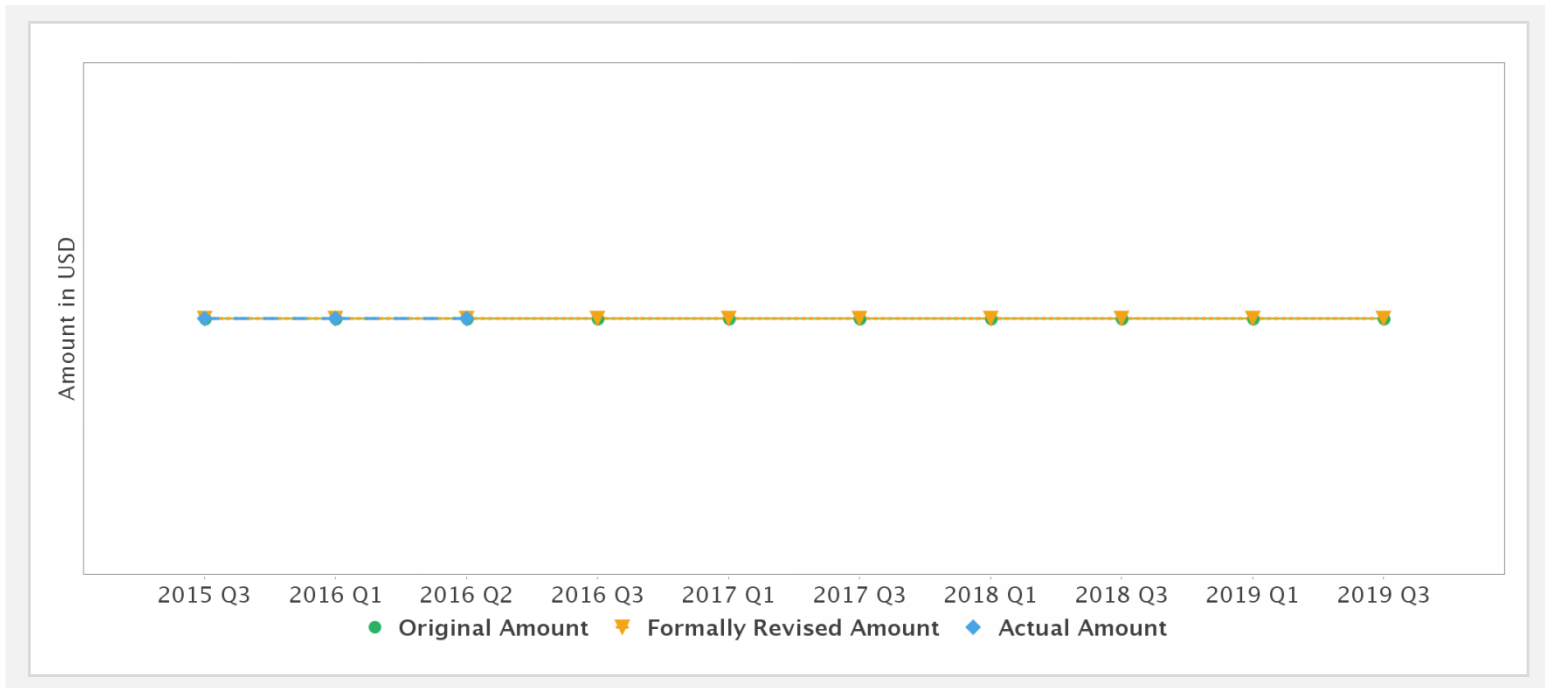
